- ⇒ **Payment must accompany application to confirm spot.**
- ⇒ **This fee is applicable for EACH 10' wide x 10' deep booth space.**
- ⇒ **Vendors are to supply their own cords, connectors and cables.**
- ⇒ **Vendors are responsible for ALL tables and coverings.**
- ⇒ **The hours of the event are going to be as follows:**
  - ⇒ **Friday October 14<sup>th</sup> – 6pm – 10pm**
  - ⇒ **Saturday October 15<sup>th</sup> - 2pm – 10pm**
  - ⇒ **Sunday October 16<sup>th</sup> - 11am - 3pm**
- ⇒ **All exhibitor booths must be in place and operational prior to the opening of the event. Vendors are required to bring their own utensils, materials, etc. (cups and ice will be provided)**
- ⇒ **Any vendor that serves alcohol is required to have all staff whom are handling alcohol in their booth “Smartserve” certified and they are expected to carry their card with them at all times. Above that, you are required to follow the AGCO guidelines. As the vendor, you can be held legally liable for the safety and sobriety of your customers. Overserving of alcoholic beverages will not be tolerated.**
- ⇒ **Due to Norfolk County requirements, each vendor must provide proof of general liability insurance in the amount of no less than 2 Million Dollars. Both “The Lions Club of Waterford” and “Norfolk County” must be named as an additional insured.**
- ⇒ **Pumpkinfest safety regulations will have to be followed.**
